DECISION OF THE SPECIAL ASSISTANT UNITED STATES ATTORNEY

___ The prosecutor will make a motion to **reduce** your fine to \$ _____. **Mail your payment to the Central Violations Bureau, P.O. Box 70939, Charlotte, NC 28272-0939. CVB must receive your payment no later than ___/___/2008, otherwise the original fine amount will be reinstated.** If, after you pay this reduced amount, you receive a *Notice to Appear at Court*, ignore it.

___ The prosecutor will move to **dismiss** your violation. If you receive a *Notice to Appear at Court*, ignore it.

___ **Request for Reduction / Request for Dismissal Denied.** The prosecutor will go forward with this case. You must pay your fine in full or you must appear in court when you receive your *Notice to Appear*.

___ **Incomplete Protest.** Your protest is incomplete, because you failed to ___ complete this form, ___ include a copy of your ticket, ___ include evidence related to your case (such as proof of insurance or vehicle registration). You may resubmit your protest with the required information. If you do not have a copy of your ticket, call 1-800-827-2982.

PLEASE NOTE: Simply submitting a Violation Protest DOES NOT clear your infraction and it DOES NOT excuse you from your scheduled court appearance. Unless you receive notice from the prosecutor that your infraction was reduced or dismissed, you must appear or pay in full.
